GMADA seals four marriage palaces

CRACKING THE whip against illegal operations, the Greater Mohali Area Development Authority (GMADA) has sealed four marriage palaces being run in violation of

the sanctioned building plans.

The marriage palaces sealed were located in different areas falling under jurisdiction of GMADA and include SS Farms on Landran-Kharar road, Satkar Marriage Palace at village Mardapur in Rajpura, Bachhal Marriage Palace at village Handesara in Dera Bassi and Hari Om Palace at village Doshpur in Dera Bassi, a GMADA officer disclosed here on Tuesday.

The field staff of the Regulatory Wing of the Estate Office had earlier inspected these marriage palaces and had found several violations at the sites. Violations

were to the nature of not obtaining necessary approvals, non submission of required documents, illegal constructions at the sites and using different facilities for the purpose other than meant for.

The owners of these marriage palaces were in past given multiple opportunities to obtain necessary approvals, but they had failed to respond. In absence of any other alternative, GMADA launched a special drive to seal these marriage palaces to ensure that the norms are complied with. The drive shall continue till all the violators are covered.

GMADA SEALS FOUR MARRIAGE PALACES

MOHALI : The Greater Mohali Area Development Authority (GMADA) on Monday sealed four marriage palaces being run in violation of the sanctioned building plans.

The palaces include SS Farms on Landran-Kharar road, Satkar Marriage Palace in Mardapur village of Rajpura, Bachhal Marriage Palace in Handesara village, Dera Bassi, and Hari Om Palace in Doshpur village of Dera Bassi.

The sealing drive comes after the regulatory wing of the GMADA estate office had inspected these marriage palaces and found violations including lack of necessary approvals, non submission of required documents, illegal constructions, and inappropriate usage of different facilities.

A GMADA spokesperson said, "The owners of the palaces were given multiple opportunities to obtain necessary approvals, but they had failed to respond, which is why the sites were sealed. The drive shall continue till all the violators are covered."

Gmada seals 4 marriage palaces

Mohali: Four teams of Greater Mohali Area Development Authority (Gmada), on Tuesday, sealed four marriage palaces being run in violation of sanctioned building plans. The sealed marriage palaces are located in different areas falling under the jurisdiction of Gmada. These include S S Farms on Landran-Kharar road, Satkar Marriage Palace, Mardapur village, tehsil Rajpura, Bachhal Marriage Palace, Handesara village, tehsil Derabassi and Hari Om Palace, Doshpur village, tehsil Derabassi.

Earlier, the field staff of the regulatory wing of the estate office inspected the marriage palaces and found several violations. These included failure to obtain necessary approvals, submit required documents, illegal construction and use of facilities for purposes other than those they were meant for, among others. In the past, owners of these marriage palaces were given multiple opportunities to obtain necessary appro-

vals, but they failed to respond. A Gmada spokesperson said they would continue to identify and seal commercial and residential establishments violating building bylaws. Residents have also been violating building bylaws and encroaching upon government land in Mohali with impunity. In June this year, MC conducted a survey and identified around 4,000 residents who have violated the norms and encroached upon government land. But no action was taken after that.

Recently, a violation came to fore in Phase 3-A, after which the area councillor-cum-deputy mayor Manjit Singh Sethi lodged a formal complaint with the local bodies department and Tripat Rajinder Singh Bajwa, cabinet minister cum co-chairman, Greater Mohali Area Development Authority (Gmada). The complaint has been made against house numbers 41, 42 and 43 in phase 3-A, where residents have included government land inside their plot by demolishing the boundary wall in violation of building bylaws.
