

In pursuance of the decision of the State Council of Ministers in its meeting held on 10<sup>th</sup> September, 2019, following shall come into force with immediate effect :-

1.0 A minimum number of 40 flats (dwelling units) shall be constructed per acre in case of sites allotted by Development Authorities to Employees Cooperative Group Societies.

2.0 There shall be 3 % reservation for Government employees in allotments made by Urban Development Authorities. 2 % reservation shall be for General category and 1 % for Reserve category being provided to Government Employees for allotment of House/Plot/Apartments and the eligibility criteria for them is as follow:-

1. Employees of Punjab Government, Employees of Boards/Corporations of Punjab Government. Employees of Punjab & Haryana High Court, Employees/officials of the Apex institutions working under cooperative Deptt. of Government of Punjab like Markfed, Milkfed, Punjab State Cooperative Bank, Housefed etc., Employees of Universities funded by Punjab Government (except Private Universities).
2. The applicant should have completed at least 5 years of regular service or should have retired within the last 5 years from the date of commencement of the scheme.
3. Persons on deputation in Punjab from Government of India or any other State will not be eligible to apply under this scheme.
4. Allotment will be made to those applicants who do not own any plot/flat in his/her name or in the name of his/her wife/ husband or dependent.
5. The Applicant should not have ever been allotted residential plot/house under discretionary quota or on the basis of preference in any scheme.
6. The applicant will submit the application with date of regular joining/retirement duly certifying him being in service from the concerned DDO of the department.


