No. 6/29/2010/6HGI/1135.—Whereas with a view to promote the Mega Housing Development Schemes in the State of Punjab, the Government of Punjab has entered into an agreement with M/s Country Colonisers Private Limited for setting up the Mega Township Project in Sector-85, tehsil and district S.A.S. Nagar.

Whereas it appears to the Government of Punjab that the land is required to be taken by the State Government at the expense of the Company, for the public purpose *viz.* the planned, harmonious and compact urban development of the area in accordance with the duly notified Master Plan of Mohali issued,—*vide* Drawing No. DTP(S)1991/2008, dated 19th November, 2008 and more specifically for the planned harmonious and compact development of Mega Township Project (M/s Country Colonisers Private Limited) in Sector-85, tehsil and district Mohali. It is hereby notified that the land in the locality described below is required for the above purpose.

This declaration is made under the provision of Section 6 of the Land Acquisition Act, 1894, to whom it may concern and under the provision of Section 7 of the said Act. The Collector Land Acquisition, Urban Development, Punjab, S.A.S. Nagar is hereby directed to take orders for the acquisition of the said land.
