No. 6/35/2010/6HGI/2984.—Whereas with a view to promote the Mega Housing Development Schemes in the State of Punjab, the Government of Punjab has entered into an agreement with M/s PUMA Realtors Pvt. Ltd. (a subsidiary of M/s IREO Funds) for setting up the Mega Township Project in Sector-99, tehsil and district S.A.S. Nagar.

Whereas it appears to the Government of Punjab that the land described in the specification given below, is likely to be needed by the State Government at the expense of the Company, for the public purpose *viz.* the planned, harmonious and compact urban development of the area in accordance with the duly notified Master Plan of Mohali issued,—*vide* Drawing No. DTP(S)1991/2008, dated 19th November, 2008 and more specifically for the planned harmonious and compact development of Mega Township Project M/s PUMA Realtors Pvt. Ltd. (a subsidiary of M/s IREO Funds) in Sector-99, tehsil and district S.A.S. Nagar. It is hereby notified that the land described in the specification given below, is likely to be needed for the aforesaid purpose.

This notification is made under the provisions of Section 4 of the Land Acquisition Act, 1894, to whom it may concern.

In exercise of the powers conferred by Section 4 of the aforesaid Act, the Governor of Punjab is pleased to authorize the Land Acquisition Collector, Urban Development, Punjab, S.A.S. Nagar, for the time being engaged in the undertaking, with their servants and workmen to enter upon and survey the land described in the specification given below and do all other acts required or permitted by that section.

Any person interested, who has any objection to the acquisition of said land mentioned below in the specification, may within thirty days of the publication of this notification in the Official Gazette, file any objections or suggestions in writing before the Land Acquisition Collector, Urban Development, Punjab, PUDA Bhawan, Sector-62, S.A.S. Nagar.

Plans of the land may be inspected in the office of the Land Acquisition Collector, Urban Development, Punjab, PUDA Bhawan, Sector 62, S.A.S. Nagar.
