Whereas the improvement/ up-gradation of these roads will involve huge expenditure from the Govt. exchequer.

Whereas with improvement/ up-gradation of these roads the value of land or building in the vicinity of these roads is likely to increase.

Whereas the development of New Chandigarh as a planned modern city will also involve huge expenditure on the construction of wide roads, parks, landscaping, provision of utilities like water supply, electricity, sewerage etc.

Whereas the development of New Chandigarh will provide better and comfortable living conditions to the public.

Therefore, in order to share the burden of expenditure of these projects with the public, the Governor of Punjab is pleased to enhance EDC charges on the following roads being up-graded by the Govt. in the State of Punjab in the following manner. With this the previous notification No.17/17/2001-5Hg2/PF/47962/1 dated 06.05.2013 of Govt. shall stand partially modified.
