No. Whereas in order to develop the Nawanshahr City and its surroundings in an orderly manner, and to prepare master plan under "The Punjab Regional and Town Planning and Development Act 1995", Local Planning Area, Nawanshahr was declared vide Notification No. 12/16/2008-4HG1/6062 Dated 11.9.08 & notification no.12/16/08-4HG1/2871 dt.31/8/10 under section 56(1)/(7) of the said act.

Whereas Chief Town Planner, Punjab, was declared as Planning Agency for aforesaid Local Planning Area under section 57 of The Punjab Regional and Town Planning and Development Act 1995 vide notification No. 12/16/2008-4HG1/6068 Dated 11.9.08.


Whereas the Planning Agency prepared the Master Plan for Local Planning Area, Nawanshahr and published the same under Section 70(3) of "The Punjab Regional and Town Planning and Development Act 1995, for inviting objections on 30/3/2011 from the general public.

Whereas objections received from the General Public have been considered by the Government in consultation with The Punjab Regional and Town Planning and Development Board, which approved the Master Plan of Nawanshahr in Board's 23rd meeting held on 23/9/2011.

Now, therefore, in exercise of powers conferred under Section 70(5) of the Punjab Regional and Town Planning and Development Act 1995, Final Master Plan, Nawanshahr comprising written report and Drawings namely Existing Landuse Plan-2010 Drawing No. D.T.P.(J) 32/2010 Dated 03-09-2010, Proposed Landuse Plan Drawing No. D.T.P.(J)18/2011 Dated 18-10-2011 are hereby notified.

It shall come into operation from the date of its publication.
