- Approval of DPRs under various components of the scheme.
- Approval of Annual Quality Monitoring Plans.
- Approval of cities/ towns selected under the scheme(s).
- 6. Reviewing progress of approved projects in the State.
- Monitoring of implementation of scheme.
- Identification and approval for utilization of govt. land of any department for construction of affordable housing under this policy, if land of ULB/ Special Development Authority is not available or more land is required.
- 9. Any other issues required for effective implementation of the scheme.
