"7.45 Under this category a strip of 30 mts on both sides of the existing bye pass is designated as restricted area where no activity related to building will take place. However different trees as notified by Govt. will be planted on these strips. Existing parks, open spaces and stadiums and other recreational areas will be retained as such."

For this purpose the provisions of the Master Plan Abhor has been amended accordingly. This amendment is hereby notified u/s 70(5) of The Punjab Regional and Town Planning and Development Act, 1995.

It shall come into operation from the date of its notification.
