

1.	Additional Chief Administrator, Amritsar Development Authority, Amritsar	Revenue Districts of Amritsar, Tarantaran, Gurdaspur and Pathankot.
2.	Additional Chief Administrator, Jalandhar Development Authority, Jalandhar	Revenue Districts of Jalandhar (excluding parts of Phillaur Tehsil in GLADA), Kapurthala and Hoshiarpur.
3.	Additional Chief Administrator, Bathinda Development Authority, Bathinda.	Revenue Districts of Bathinda, Mansa, Shri Muksar Sahib, Faridkot and Fazilka
4.	Additional Chief Administrator, Ludhiana Development Authority, Ludhiana.	Revenue Districts of Ludhiana, Moga, S.B.S. Nagar (Nawanshaher), Part of Tehsil Phillaur of Jalandhar District and Ferozpur.
5.	Additional Chief Administrator, Patiala Development Authority, Patiala	Revenue Districts of Fatehgarh Sahib and Patiala upto 2 Km of South of NH-1, whole of Sangrur and Barnala Districts.
6.	Additional Chief Administrator, Greater Mohali Area Development Authority, Mohali	Revenue Districts of Mohali and Ropar, parts of Fatehgarh Sahib and Patiala District 2Km Beyond NH-1.
