5HgII/5094 dated 16-11-2012 has formulated a policy to regularize the un-authorized existing Marriage Palaces and setting up of New Marriage Palaces in the State of Punjab which was amended vide notification on 7-01-2013

Whereas while implementing the proposals of this policy it was brought to the notice of Government of Punjab that this policy cannot be implemented in the Regional Plan GMADA as well as in Master Plans of 6 cities namely S.A.S.Nagar, Mullanpur, Banur, Zirakpur, Kharar and Derabassi falling within Regional Plan GMADA because there is no provision in these Master Plans for setting up of Marriage Palaces.

Whereas the Government of Punjab keeping in view the social needs of the public of this region has decided to make provisions for setting up of Marriage Palaces in the above said Master Plans.

Therefore, Government in consultation with 'The Punjab Regional and Town Planning and Development Board' in its 27th meeting held on 23-12-2013 has approved the following amendment u/s 76 of the Act ibid in Regional Plan GMADA and in the Master Plans of S.A.S.Nagar, Mullanpur (Now new Chandigarh), Banur, Zirakpur, Kharar and Derabassi falling within GMADA Regional Plan:

1) Master Plan Mullanpur

In Master Plan Mullanpur (now New Chandigarh) new marriage Palaces shall only be permitted in mixed land use and residential zone on PR-4 road with Minimum plot size of 5 acres. Out of the total parking required minimum 50% shall be provided in the basement.

2) Master Plan S.A.S.Nagar

In Master Plan SAS Nagar the new marriage palaces shall be permitted in mix land use, commercial, industrial and agriculture zone only on minimum plot size shall be 5 acres. Out of the total parking required minimum 50% shall be provided in the basement.

3) Master plan Zirakpur, Banur, Derabassi and Kharar

The new marriage palaces in these Master Plans shall be permitted as per the provisions of the marriage palace policy notified vide Government of Punjab notification dated 16.11.2012 (amended on 07.01.2013)

4) Regional Plan GMADA

In Regional Plan the existing unauthorized marriage palaces shall be regularized and new marriage palaces shall be permitted as per the provisions of the marriage palace policy notified vide Government of Punjab notification dated 16.11.2012 (amended on 07.01.2013)

It shall come into operation from the date of its notification.
