Revision of Extension Policy and Transfer  
Policy of the Board.

This is in continuation of the FAX message  
sent vide No. Ad.O.(HQ)95/130 dated 17.1.95 on the subject  
cited above.

2. With the approval of the Finance and Accounts  
Committee and the Board some amendments have been made in  
the existing policies of the Board regarding extension in  
construction period of plots as well as transfer of plots.  
These are as follows:-

i. Extension Policy:

The extension Policy has been amended as  
follows:

(a) The general extension period allowed to old  
allottees of plots with effect from 1.1.88  
which was to expire on 31.12.95, has been  
extended to 31.12.96 @ Rs 16/- per sq.yd. for the year 1995  
and Rs 20/- per sq.yd. for 1996.

(b) Extension fees for commercial plots have been  
revised as follows:

Year	Rate	
1st	1%	of auctioned price.
2nd	1½%	-do-
3rd	2%	-do-
4th	2½%	-do-
5th	3%	-do-
6th	3½%	-do-
7th	4%	-do-
8th	4½%	-do-

The above revised rates would be applicable

2. ~~with the previous~~  
strictly  
only to allotments/auction purchases made on  
or after 15.12.94 and in respect of  
allotments/auction purchases made before this date the old rates would apply.

There is no change in the remaining provisions of the existing Extension Policy.

#### 2. Transfer Policy:

The transfer policy is revised as follows:

(a) No transfer under the policy would be permitted after six years from the date of allotment.

(b) The transfer fees are revised as follows:

i) For residential plots : 1.5% of the allotment price subject to the following minimum:

500 Sq.Yds.	Rs. 8400/-
400 Sq.Yds.	Rs. 6500/-
250 Sq.Yds.	Rs. 4500/-
200 Sq.Yds.	Rs. 3100/-
100 Sq.yds.	Rs. 1600/-

ii) For Commercial plots: 3% of the auction price subject to the following minimum:

Shop cum flat :	Rs. 5100/-
Booth :	Rs. 1000/-

iii) For family transfers:

Residential :	Rs. 250/-
Commercial :	Rs. 500/-

The above changes would be applicable in respect of all allotments, and there is no cut off date as in the case of Extension Policy.

There is no change in the remaining provisions of the existing Transfer Policy.

Estate Officers may ensure that the revised provisions of the policies are implemented strictly.
