## Regarding amendment in Master Plan Patiala

u/s 70 (5) of The Punjab Regional and Town Planning and Development Act, 1995 vide notification no. 6422 CTP(Pb) SP-40 dated 23-8-2010. During its implementation it has come to the notice of the government that the major portion of 100'-0" wide proposed road along the revenue boundary of village Farm Bahadurgarh and Bir Bahadurgarh is passing through the land of Gurudwara Bahadurgarh Sahib and a portion of this road passes through Good Earth Industrial Park colony regularized under policy for regularization of unauthorized colonies in the state of Punjab. Hence the implementation of this road on site is not feasible.

Therefore, keeping in view the permission already granted to Good Earth industrial park colony by different departments, the Government u/s 76 of the Act ibid in consultation with The Punjab Regional and Town Planning and Development Board' in its 29th meeting held on 15-04-2015, has decided to realign the above said 100"-0" wide proposed road in Master Plan Patiala in public interest. The re-alignment of this 100'-0" wide road has been proposed along the existing village link road starting from NH-64 and passing by the abadi of village Bir Bahadurgarh and terminating into the already proposed 100'-0" wide road running parallel to Patiala-Rajpura railway line, as shown on Transport Network Plan drawing no. D.T.P. (P) 3525/10 dated: 04-08-10 revised on 09-09-14.

It shall come into operation from the date of its notification.
