Whereas in order to promote industrial development in the State of Punjab, the Govt., besides extending various other incentives, has already exempted Change of Land Use (CLU) charges for setting up of industries in the State of Punjab and only nominal External Development Charges (hereinafter called EDC) and Social Infrastructure Fund (hereinafter called SIF) are being charged.

Whereas to promote Food Processing Projects in the State of Punjab, the Govt. intends to further grant certain incentives to Mega Food Park Projects in the State. Therefore, the Governor of Punjab is pleased to exempt EDC for setting up of the following two Mega Food Park Projects in the State and only SIF shall be chargeable as per policy of the Govt.

1. Mega Food Park Project, Vill: Laddhowal, Distt. Ludhiana to be set up by Punjab Agro Industries Corporation Limited.
2. Mega Food Park Project, Vill: Rihana Jattan, Distt. Hoshiarpur to be set up by Sukhjit Starch Limited.


With this the Notification No.17/17/01/5Hg2/327 dated 11.01.2008 shall stand partially amended to the extent as mentioned above.
