## Sub:- Social Housing Reduction of Interest rates- regarding.

As you are aware, HUDCO has been always in the forefront in promoting housing with a particular focus on the weaker sections of the society. It is reflected in the fact that over 90% of the housing units supported by HUDCO pertain to the Economically Weaker Section (EWS) and Low Income Groups (LIG). In line with the current focus of the Government towards addressing the shelter requirements of the weaker sections and also the crucial role the housing sector plays in Nation Building HUDCO Board in its Meeting held on 24<sup>th</sup> August, 2009, has decided to extend loan assistance for social housing categories at substantially lower rates as compared to the present as indicated below:

## **Social Housing**

- 1. I would like to specially highlight that the above lending rates are lesser than the borrowing cost of HUDCO and in addition HUDCO is not recovering its administrative cost or having any spread or any margin for NPA cost.
- 2. Achieving the objective of shelter for all would only possible with the involvement of all the stake holders in the shelter delivery process. Accordingly, towards promoting affordable housing through private developers builders and as part of the Affordable Housing in Partnership scheme, HUDCO would extend loans for up to Rs. 15 lakh as under:-

In its efforts towards improving the access of HUDCO loan assistance to the socially disadvantaged sections of the society, HUDCO has also effected reduction in the interest rates under HUDCO Niwas for individual beneficiaries with addition reduction for Women beneficiaries and all beneficiaries belonging to SC/ST. The details are as under:-

4. In the light of the above, I would request that the State Government may like to avail the concessional loan assistance by taking up social housing programmes for weaker section covering EWS and LIG categories on a large scale and also under the other categories at the highly affordable rates indicated above.

I would like to once again reiterate HUDCOs continued commitment for facilitating affordable shelter for all and assure that HUDCO would stand by your efforts in this regard. I have asked HUDCO Regional Chief to personally meet you and brief on the above as well.
