- (ii) Estimated number of affected families and number of families likely to be displaced
- (iii) Understand extent of land, public and private, houses, settlement and other common properties likely to be affected by the proposed acquisition
 - (iv) Understand extent of land, which is bare minimum needed for the project
 - (v) Analyse alternate place (if any)
- (vi) Study of the Social impacts, nature and cost of addressing them and impact of these costs on the overall cost of the project vis-àvis the benefit of the project.

This notification is made under the provisions of Section-4(I) of THE RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT 2013 (ACT NO. 30 OF 2013).

It is hereby notified that the acquisition of land under the proposed project falls under the provision of section 2(I)-(e) project for planned development. Thus, under the provisions of section 2 (2), consent of Gram Sabha/land owners is not required for this project. It is to be noted that entire SIA shall be carried out in consultation with the Panchayat and land owners.



The SIA shall commence from the date of issue of SIA notification, which shall be completed within 6 months. The important output of the SIA shall include SIA report and SIMP along with the disclosure as prescribed under section 6 of the said act.
